



Ordinance No. SP- 81, S-93

ORDINANCE

REQUIRING MEDICAL EXAMINATION FOR POSSIBLE DRUG ADDICTION AND ALCOHOLISM OF ALL UNIFORMED MEN OF CENTRAL POLICE DISTRICT AND QUEZON CITY FIRE STATION, PHILIPPINE NATIONAL POLICE, AND FORFEITURE OF THE INCENTIVE ALLOWANCE GRANTED BY THE QUEZON CITY GOVERNMENT FOR THOSE FOUND POSITIVE FOR DRUG ADDICTION AND ALCOHOLISM.

WHEREAS, under Ordinance No. SP-21, S-92 otherwise known as Supplemental Budget No. 1 for the calendar year 1992 involving the sum of TWO HUNDRED SEVENTY-THREE MILLION NINE HUNDRED THIRTY-FIVE THOUSAND SIX HUNDRED NINETY-ONE PESOS (P273,935,691.00) and appropriating the necessary funds for the purpose and Ordinance No. SP-39, S-92 otherwise known as the Annual Budget of the Quezon City Government for calendar year 1993 in the total amount of TWO BILLION TWENTY-THREE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (P2,023,680,000) covering the various expenditures of the City Government for the year 1993, extended financial assistance in the form of Incentive Allowance for TWO THOUSAND SIXTY-TWO (2,062) uniformed men of Central Police District and Quezon City Fire Station, Philippine National Police, stationed in Quezon City, ONE THOUSAND PESOS (P1,000.00) each every month starting July 1, 1992 up to December 31, 1993;

WHEREAS, the Sangguniang Panlungsod, as the legislative body of the City has the duty to enact ordinances intended to prevent, suppress and impose appropriate penalties for habitual drunkenness in public places and drug addiction and such other activities inimical to the welfare and morals of the inhabitants of the City;

WHEREAS, it is an undisputed fact that some of the crimes, heinous or

and continuously being committed by persons some of whom are men in uniform who are under the influence of liquor and prohibited drugs;

WHEREAS, to preserve or maintain peace and order, and in order not to render some of the taxes being paid by the taxpayers of Quezon City futile, it is imperative therefore, that these uniformed men receiving incentive allowance from the Quezon City Government be compelled to undergo drug and alcoholic tests;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. That all uniformed men of Central Police District and Quezon City Fire Station, Philippine National Police, who are entitled to receive the incentive allowance under Ordinance Nos. SP-21, S-92 and SP-39, S-92 shall undergo compulsory drug and alcoholic tests with the National Bureau of Investigation or the Philippine National Police Crime Laboratory Service, Camp Crame, Quezon City.

SECTION 2. That non-compliance to Section 1 hereof within one (1) month from the effectivity of this Ordinance or those found positive for drug addiction and/or alcoholism, shall not be entitled to receive the incentive allowance provided for under the aforesaid ordinances.

SECTION 3. That these uniformed men, within two (2) months from the effectivity of this Ordinance, shall submit written certification under oath duly issued by either of the aforesaid agencies to the Quezon City Treasurer, Office of the Mayor, stating therein the result of the compulsory drug and alcoholic tests.
