ORDINANCE

INCREASING THE MONTHLY COMMUTABLE ALLOWANCE OF THE CITY MAYOR, VICE MAYOR AND MEMBERS OF THE CITY COUNCIL, AND APPROPRIATING THE SUM OF ONE MILLION TWO HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FIFTY PESOS (P1,288,750.00) FOR THE PURPOSE.

WHEREAS, considering the high cost of living as well as the growing complexity in human activity in such a huge city as Quezon City, the present rate of commutable allowances of the City Mayor, the Vice Mayor and the members of the City Council are no longer responsive to the changing times and the multifarious problems of the growing population which deserves no less the full and unqualified attention of said city officials;

WHEREAS, if these city officials are to adequately respond to the ever pressing needs of the City inhabitants, they are to be granted a more realistic rates of allowances;

WHEREAS, the grant^{and} or adjustments of said allowances may be provided for by law or ordinance under Sec. 173 of the Local Government Code;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. The monthly commutable allowances of the City Mayor, Vice Mayor and members of the City Council are hereby adjusted as follows:

SECTION 2. There is hereby appropriated from the General fund of the City the sum of ONE MILLION TWO HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FIFTY PESOS (P1,288,750.00) out of any available or unappropriated funds in the City Treasury, SIX HUNDRED TWENTY-FIVE THOUSAND SEVEN HUNDRED FIFTY PESOS (P625,750.00), thereof to be made available to cover the prior year's obligations by way of differentials in favor of said officials from February to December, 1988 and the sum of SIX HUNDRED SIXTY THREE THOUSAND PESOS (P663,000.00) to be made available for said allowances for the year 1988.

SECTION 3. All ordinances, resolutions and issuances of any part or parts thereof which are inconsistent with this Ordinance or any part hereof are hereby repealed, amended or modified accordingly.

SECTION 4. This Ordinance shall take retroactive effect to February, 1988.
