ORDINANCE

CREATING SIXTEEN (16) ADDITIONAL CONTRACTUAL POSITIONS UNDER THE HEALTH DEPARTMENT FOR THE OPERATION ON A 24-HOUR BASIS OF THE HEALTH CENTERS IN TATALON, GALAS, IMELDA (KALAYAAN) AND CUBAO, ALL LOCATED IN DISTRICT FOUR (IV) OF QUEZON CITY AND APPROPRIATING THE SUM OF FIVE HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED PESOS (P566,400.00) FOR THE CREATION THEREOF.

WHEREAS, after further study by the Health Department, the operation of each health center on a 24-hour basis requires one (1) more team of medical personnel in order to complete the following schedule:

WHEREAS, the above-mentioned schedule is based on the forty (40) hour maximum working hours per week according to the Labor Code.



NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. There is hereby created sixteen (16) additional contractual positions to supplement the existing medical teams of the four pilot 24-hour health centers located in the Fourth (4th) District of Quezon City pursuant to Ordinance No. 6, S-88 to be assigned as follows:

SECTION 2. The contractual appointment issued in pursuance herewith shall be for a period not exceeding six (6) months in the discretion of the appointing authority.

SECTION 3. There is hereby appropriated the sum of FIVE HUNDRED SIXTY-SIX THOUSAND FOUR HUNDRED PESOS (P566,400.00) for the payment of the compensation and other benefits of the contractual position herein created.



SECTION 4. This Ordinance shall take effect upon its approval.
