SECRETARY FOR FURNITURE AND EQUIPMENT, AND RE-APPROILLATING THE SAME AMOUNT FOR THE PURCHASE OF ONE (1)

SERVICE VEHICLE (JEEP) FOR THE USE OF SAID OFFICE.

WHEREAS, the general secretariat of the City Council of Quezon City, the Office of the City Secretary renders secretarial and other support services to the law-making body of the Quezon City Government;

WHEREAS, in connection with or during public hearings or dialogues conducted by the City Council in aid of legislation, the Office of the City Secretary is tasked to see to it that all sectors/persons concerned (business sector, social/civic/religious groups, barangay officials and all concerned segment/s of the general public) are invited or duly notified thereof;

WHEREAS, the Office of the City Secretary presently does not even have a single service vehicle to be able to efficiently and seasonably undertake the aforesaid tasks not to mention the need for the timely transmittal/delivery/dissemination of duly enacted ordinances/resolutions to public officials and all concerned for their information, consideration and/or enforcement, thus hampering the effectiveness of the Secretary' Office in this area to the great prejudice of the service;

WHEREAS, there is enough capital outlay provisions for the Office of the City Secretary carried under the 1988 executive budget for furniture and equipments from which to draw the fundings, without necessitating additional appropriations but merely a measure for the reversion/re-appropriation thereof;

NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session assembled:

SECTION 1. The amount of One Hundred Thousand Pesos out of the capital outlay appropriations of the Office of the City Secretary under furnitures and equipment covered by the 1988 Executive Budget is

hereby reverted to the General Fund.

SECTION 2. The amount of One Hundred Thousand Pesos so reverted under Section One hereof is hereby re-appropriated for the purchase of one (1) service vehicle (jeep) for the use by the Office of the City Secretary.

SECTION 3. This Ordinance shall take effect upon its approval.
