ORDINANCE

AUTHORIZING THE ACQUISITION BY QUEZON CITY OF A ROAD RIGHT-OF-WAY LEADING TO CAMPO II, TALIPAPA, QUEZON CITY, THRU EXPROPRIATION OR BY NEGOTIATED SALE, AND APPROPRIATING THE SUM OF ONE HUNDRED FOURTEEN THOUSAND TWO HUNDRED FIFTY PESOS (P114,250.00) FOR THE PURPOSE.

WHEREAS, Campo II, Talipapa, Quezon City is an isolated sitio in this City;

WHEREAS, the only means of egress to Tandang Sora Avenue, a public highway, of the residents therein is an existing road traversing the mid-portion of the property of the Manila Paper Mills, Incorporated;

WHEREAS, the aforementioned lot owner intended to close this existing road and offered an alternate route which is only two (2) meters wide;

WHEREAS, the residents of Campo II filed a complaint against the lot owner, Manila Paper Mills, Incorporated, with the Regional Trial Court, Branch 107, Quezon City, last June 5, 1987 to restrain the lot owner from closing said road, but, upon mutual agreement of both parties, the complaint was dismissed last June 9, 1988 without prejudice to the filing of expropriation proceedings;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. The acquisition thru expropriation or by negotiated sale of a road right-of-way with an estimated total area of One Thousand One Hundred Twelve (1,112) square meters owned by Manila Paper Mills, Incorporated, leading to Campo II, Talipapa, Quezon City, is hereby authorized.



SECTION 2. There is hereby appropriated from any available funds in the City Treasury the sum of One Hundred Fourteen Thousand Two Hundred Fifty Pesos (P114, 250.00), or as much thereof as may be necessary, to cover the cost of acquisition of the road right-of-way authorized under Section One hereof.

SECTION 3. The City Mayor is hereby authorized to enter into a contract necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall take effect upon its approval.
