WHEREAS, Item 1(d) of Supplemental Budget No. 1
Calendar Year 1988, allocates the amount of One Million
Five Hundred Thousand (P1,500,000.00) for the construction/
improvement of San Jose High School;

WHEREAS, "San Jose High School" located inside the
compound of San Jose Elementary School is actually the
annex of E. Rodriguez Jr. High School as per certification
of the Quezon City Schools Division Superintendent dated
January 6, 1989;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City
in session assembled;

SECTION 1. Item 1(d) of Supplemental Budget No.1,
Calendar Year 1988 (Ordinance No. NC-47, S-88) for
Infrastructure Fund is hereby amended to read as follows:

1. Appropriating for construction/improvement of
the following schools at One Million Five Hundred
Thousand Pesos (P1,500,000.00) each;

- a. Don Mariano High School Commonwealth Annex
- b. Pasong Tamo High School
- c. Quirino High School
- d. E. Rodriguez Jr. High School- San Jose Annex
