Be it ordained by the City Council of Quezon City
in session assembled:

SECTION 1. A seal showing the Coat of Arms of
Quezon City enclosed by a circle wherein the words
SANGGUNIANG PANLUNGSOD, LUNGSOD QUEZON are inscribed
and the year 1939 indicated below the Coat of Arms, is
hereby adopted as the official seal of the City Council
of Quezon City.

SECTION 2. The official seal adopted in Section
One hereof shall be kept by the City Secretary who
shall cause the same to be stamped on all ordinances,
resolutions and other official papers and documents of
the City Council.

SECTION 3. The unauthorized use of the official
seal herein above provided by persons other than the
official keeper thereof for unlawful purpose shall be
punishable by imprisonment for a period of not in ex-
cess of ten (10) days of arresto menor or a fine not
exceeding ONE THOUSAND PESOS (P1,000.00), or both
such imprisonment and fine in the discretion of the
court.

SECTION 4. This Ordinance shall take effect upon
its approval.
