Ordinance No. NC-106, S - 89

ORDINANCE

REQUIRING ALL OWNERS OF LAND, BUSINESS ESTABLISH-MENTS AND RESIDENTIAL HOUSES OR LESSEES THEREOF TO UNDERTAKE THE CLEANLINESS OF THE AREAS WITHIN THEIR PREMISES; PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, disposal of garbage and cleanliness of our surroundings have been the major problem and concern not only of the government but of the citizenry as well;

WHEREAS, our City Government has initiated several plans to make our City clean in line with its sanitation and beautification program;

WHEREAS, the government and the citizens should cooperate in maintaning the cleanliness within their own premises in order to achieve the avowed objective of the City Government in making our City clean and a nice place to live in;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. It shall be the duty and obligation of every owner of land, business establishments and residential houses in quezon City or lessees thereof to maintain the cleanliness of the areas within their premises including the sidewalks and street gutters fronting their premises and to keep a garbarge can or receptacle for disposal of their garbage.

SECTION 2. It shall be unlawful for the persons mentioned in section One hereof to throw and/or dump their garbage in any place other than their own garbage can or receptacle.

SECTION 3. Violation of this Ordinance shall be penalized by imprisonment of not more than ten (10) days or a fine of not more than Five Hundred Pesos (₱500,00), or both such imprisonment or fine in the discretion of the court; Provided, that if the violation is committed by a juridical person, the penalty herein will be imposed on the President, the manager or the person in-charge thereof.
