THE NECESSARY FUNDS THERLEOR.

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. Supplemental Budget No. 2 for Calendar Year 1989 involving FIFTY-ONE MILLION SIX HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED SEVENTY-FIVE PESOS (P51,698, 575,00) under the General Fund and TWENTY-FIVE MILLION SEVEN HUNDRED THOUSAND NINE HUNDRED PESOS (P25,700,900,00) under the Infrastructure Fund to cover the prior years obligations and current year expenses of the various offices and activities of the City Government is hereby approved. The document containing the purposes and details of the expenditures is hereby attached and made an integral part of this ordinance.

SECTION 2. There is hereby appropriated the sum of SEVENTY-SEVEN MILLION THREE HUNDRED NINETY-NINE THOUSAND FOUR HUNDRED SEVENTY-FIVE PESOS (P77,399,475.00), TWENTY-FIVE MILLION SEVEN HUNDRED THOUSAND NINE HUNDRED PESOS (P25,700,900.00) of which shall be made available to cover the expenses under the Infrastructure Fund and the balance to be made available to cover the expenses under the General Fund provided for under Section One hereof, the amount to be taken from the following sources:

- 1. Unappropriated balance under SB No. 1
- Reverted appropriationsUnderestimated revenues

4. Reverted appropriations from the Engineering
Department under the Infrastructure Fund.
