IN CUBAO, QUEZON CITY, TO MAYOR I. SANTOS DIAZ STREET.

WHEREAS, the late Mayor I. Santos Diaz served as  
the Mayor of Quezon City from January, 1950 to December,  
1953;

WHEREAS, in 1952 he was voted as "Most Outstand-  
ing Mayor" of Quezon City and again in 1964 was  
awarded the Highest Distinction for Outstanding ser-  
vices and was conferred Certificate of Appreciation  
for exemplary devotion to service as Mayor of Quezon  
City;

WHEREAS, the outlying streets in Banahaw area in  
Cubao, this City, where the late Mayor I. Santos Diaz  
and his family lived have been renamed after City  
Government personalities such as Mayor Ponciano  
Bernardo and former City Councilor Pedro Tuazon;

WHEREAS, it is believed that the late Mayor I.  
Santos Diaz deserved no less honor by renaming Banahaw,  
a verified city street, after his name;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City  
in session assembled:

SECTION 1. The name of Banahaw Street in Cubao,  
Quezon City, is hereby changed to Mayor I. Santos  
Diaz Street.
