## ORDINANCE

EXTENDING RELIEF IN THE FORM OF FINANCIAL ASSISTANCE IN THE AMOUNT NOT EXCEEDING EIGHT HUNDRED SEVENTY-FIVE THOUSAND PESOS (#875,000.00) TO THE FIRE VICTIMS OF BARANGAYS PINAHAN AND DAMAYANG LAGI, QUEZON CITY, TO BE TAKEN FROM THE 1989 CALAMITY FUNDS OF THE QUEZON CITY GOVERNMENT.

WHEREAS, it is moral and legal duty of the state to do everything possible within its capability to provide for and look after the health, eafety, comfort and general well being of the community;

WHEREAS, it is likewise the duty of the government to protect the public from fires and to prevent and mitigate the effects thereof, including floods, storms, earthquakes and other unforseen calamities;

WHEREAS, the relief that may be extended by the City Government to its inhabitants especially during times of crisis and emergencies will go a long way in alleviating the hardships and difficulties of the public;

## NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session assembled:

SECTION 1. A financial assistance of Five Hundred Pesos (\$500.00) to qualified beneficiaries as contained in the Social Welfare Office list which is made integral part of this Ordinance is hereby authorized to be extended, subject to normal government accounting and auditing procedures, to the victims of the recent fire that hit Barangay Pinahan on November 17, 1989 and Barangay Damayang Lagi on November 3, 1989 in Quezon City, which total amount shall not exceed Eight Hundred Seventy-Five Thousand Pesos (\$875,000.00).

RECE FORM 4: 00 PM

SECTION 2. The fire victims in whose favor the financial assistance provided in Section One horeof is intended shall be ascertained by the Social Welfare Office of the Quezon City Government and approved by the City Mayor and the release of the same shall be coordinated with the Deputy Mayor concerned; Provided, that the fire victim shall secure the necessary identification from the barangay captain concerned.

SECTION 3. The financial assistance of Eight Hundred Seventy-Five Thousand Pesos (#875,000,00) under Section One hereof shall come from the 1989 Calamity Fund of the Quezon City Government.

SECTION 4. The duly cortified beneficiaries who failed to claim such assistance up to December 31, 1989, shall forfeit the financial assistance in the said amount and the same shall be reverted to the City Treasury.

SECTION 5. This Ordinance shall take effect upon its approval.
