APPROVING SUPPLEMENTAL BUDGET NO. 5 (GENERAL FUND)
SERIES OF 1989INVOLVING THE TOTAL SUM OF TWENTY-THREE
MILLION ONE HUNDRED ELEVEN THOUSAND ONE HUNDRED THIRTYFIVE PESOS (P23, 111, 135.00) TO COVER CERTAIN PRIOR
YEARS OBLIGATIONS AND CURRENT YEAR EXPENSES OF THE CITY
GOVERNMENT AND APPROPRIATING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Quezon City in session assembled:

Section 1. Supplemental Budget No. 5 (General Fund) involving the sum of Twenty-Three Million One Hundred Eleven Thousand One Hundred Thirty-Five Pesos (P23,111,135.00) series of 1989 covering certain prior years obligations and current years expenses of the City Government is hereby approved, the document containing the detailed statements of expenses is attached herewith and made an integral part hereof.

Section 2. There is hereby reverted to the General Fund the following amounts:

- 1. From Mini Industrial-Other P5,000,000.00 Services Fand and Land Improvement Outlay
- 2. Special Activities Fund App 625,000.00
- 3. Socialized Housing 4,600,000.00
- 4. Urban Poor-Trucking 129,000.00
- 5. Sama-Sama Livelihood Project Under S.B. No.2 703,300.00

Total-- P11,048,300.00

Section 3. There is hereby appropriated the total sum of Twenty Three Million One Hundred Eleven Thousand One Hundred Thirty Five Pesos (P23,111,135.00), or so much thereof as may be necessary, which shall be made available to cover the expenses under Section One hereof, the total sum to be taken from the amounts reverted under Section Two hereof, from the unappropriated balance under S.B. No. 4 and the underestimated Ord. No NC-123, S-89 Page -2-

revenue certified as available for the appropriations by the City Treasurer, the document containing the detailed statements of which is attached herewith and made an integral part hereof.

Section 4. This Ordinance shall take effect upon its approval.
