ORDINANCE

GIVING CASH ASSISTANCE OF FIVE HUNDRED PESOS (P500.00) FROM THE 1989 CALAMITY FUND OF QUEZON CITY GOVERNMENT TO EACH OF THE ~~TWENTY~~ FIVE (25) FAMILIES WHO ARE FIRE VICTIMS IN MENDEZ ROAD, BARANGAY BAESA, QUEZON CITY.

WHEREAS, the twenty-five (25) families named hereunder suffered loss of property and deprivation of basic necessities in life due to the fire that razed their houses in Mendez Road, Baesa, Quezon City on November 25, 1989 at about 10:20 in the morning;

WHEREAS, the Quezon City Government has set aside a Calamity Fund for 1989 to alleviate the sufferings of victims of calamity like fire;

Whereas, in their letter dated December 12, 1989, copy is hereto attached and made an integral part hereof, His Honor, Mayor Brigido R. Simon, Jr., has approved the victims' request for financial assistance;

NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session assembled;

Section 1. There is hereby given cash aid of Five Hundred Pesos (P500.00) each to fire-victim families of: CRIS RIMANDIMAN, MANUEL CAYANAN, SALVADOR VELASCO, ERNESTO JOSUE, MRS. CHARITO BARASI, MRS. LUISA BACUNGAN, FRANCISCO AUDITOR, MRS. LYDIA NARON, MRS. NANET, JAIME ALAGAR, MRS. VISITACION MACAPAGAT, MRS. EVELYN GLUDO, VENESIO ALBARIO, NENE SORIANO, LUCITA SORIANO, PEDRITO GUERRERO, MRS. RUBIE LOPAZ, ISABELO MAPANAO, MRS. EUFRONIA DUMIQUIL, SERGIO BALANA, MRS. AIDA MARCO, ELMER LUNA, RENATO PALACIO, MRS. ISABEL MURAO and JERONDIO HAK-HAK.

SECTION 2. The cash assistance of Five Hundred Pesos (₱500.00) shall be received from the Social Welfare Office of Quezon City upon approval by the City Mayor.

SECTION 3. The financial assistance shall come from the 1989 Calamity Fund of the Quezon City Government.

SECTION 4. This Ordinance shall take effect upon its approval.
