ORDINANCE

CREATING, IN LIEU OF THE PRESENT ONE (1) POSITION OF CITY ADMINISTRATOR OF THE QUEZON CITY GOVERNMENT, THE POSITIONS OF CITY ADMINISTRATOR FOR GENERAL AFFAIRS, CITY ADMINISTRATOR FOR OPERATIONS, CITY ADMINISTRATOR FOR FISCAL AFFAIRS AND THE POSITION OF ANOTHER ASSISTANT SECRETARY TO THE CITY MAYOR AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

WHEREAS, with the City's fast changing environs brought about by its size and locations, the present organizational set-up of the Quezon City Government has become marginally responsive and lack structural strength to carry long-term development programs;

WHEREAS, the City Mayor, given a fresh mandate by the residents in the January 18, 1988 elections, has initiated a reorganization study in order to come up with a new City Government organizational framework capable of adequately rendering more basic services to the people as well as carrying planned growth over the years to come;

NOW, THEREFORE,

Be it enacted by the City Council of Quezon City in session assembled:


SECTION 1. In lieu of the present one (1) position of City Administrator of the Quezon City Government, there are hereby created the positions of City Administrator for General Affairs, City Administrator for Operations, City Administrator for Fiscal Affairs and the position of another Assistant Secretary to the City Mayor, with all the duties and functions defined and delineated under the Quezon City Charter and Local Government Code and other applicable ordinances.


SECTION 2. The salaries corresponding to the positions created under Section One hereof and the adjusted salaries of the Secretary to City Mayor and the present Assistant Secretary to the City Mayor as contained in the herein attached list which is made an integral part of this Ordinance, are hereby approved; Provided, That the two (2) Assistant Secretaries to the City Mayor shall be considered as Assistant Department Heads for purposes of transportation and representation allowances.

SECTION 3. There is hereby appropriated from any available funds in the General Fund of the City the sum of ONE MILLION PESOS (P1,000,000.00), or so much thereof as may be necessary, to cover the payment of the salaries and allowances of the positions created hereunder including government shares in the insurance premiums and other mandatory expenses for the current year.


SECTION 4. This Ordinance shall take effect upon its approval.


