Be it enacted by the City Council of Quezon City in session assembled:

Section 1. There is hereby created under the Health Department the following contractual positions necessary for the operation on a 24-hour basis of the health centers located in the four (4) districts of Quezon City, to wit:

PROVIDED, that the contract of appointment issued in pursuance herewith shall be for a period not exceeding six months renewable for another period not exceeding six months in the discretion of the appointing authority.

Section 2. The contractual positions created for Tatalon, Galas, Imelda (Kalayaan) and Cubao of the 4th District are hereby implemented while those in San Francisco Del Monte and Bago-Bantay of the 1st District, Commonwealth and Banlat of the 2nd District, Ermin Garcia and Project 4 of the 3rd District shall be implemented in the next regular budget.

Section 3. The amount necessary for the payment of the compensation and other benefits of the positions created for the 4th District under Section 1 hereof shall be charged against the lump-sum appropriation provided for the purpose under Supplemental Budget No. 3 as approved under Ordinance No. 52, 5-88.

Section 4. This ordinance shall take effect upon its approval.
