ORDINANCE

GRANTING A TEN PERCENT/TWO-STEP ACROSS-THE-BOARD SALARY INCREASE TO ALL EMPLOYEES OF THE QUEZON CITY GOVERNMENT WITH CERTAIN EXCEPTIONS EFFECTIVE JANUARY 1, 1988 PURSUANT TO NATIONAL COMPENSATION CIRCULAR NO. 51; AND APPROPRIATING THE SUM OF FIFTEEN MILLION PESOS (P15,000,000) FOR THE PURPOSE.

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. All employees of the Quezon City Government, whether under permanent, temporary, contractual or emergency status, with the exception of Department Heads, Assistant Department Heads, Consultants and Chiefs of Office whose salary rate exceeds Three Thousand Six Hundred Sixteen Pesos (P3,616.00) per month, are hereby granted a ten percent (10%) two-step across-the board salary increase effective January 1, 1988 pursuant to the provisions of National Compensation Circular No. 51 of the Department of Budget and Management and in implementation of Resolution No. NC-45, 5-88 of the City Council; PROVIDED, that the adjustment shall be based on the basic salary/wage prevailing as of December 31, 1987.

SECTION 2. There is hereby appropriated the sum of Fifteen Million Pesos (P15,000,000.00), or so much thereof as may be necessary, to cover the payment of the salary adjustments provided for under Section 1 hereof, the amount of Thirteen Million Eight Hundred Thousand Pesos (13,800,000.00) to be taken from the General Fund and One Million Two Hundred Thousand Pesos (1,200,000.00) from the Infrastructure Fund certified as available by the City Treasurer; PROVIDED, That the amount taken from the Infrastructure Fund shall be made available for the payment of the salary difference of employees under such fund.
