Hererra, Melencio M. Castelo, Vicente D. Biglang-Awa, Isidro R. Saludes, Edgardo S. Serrano, Tomas P. Castro, Jose J. Paculdo, Eduardo, F. David, Cielito "Mahal" Del Mundo and Ricardo R. Del Rosario. Be it ordained by the City Council of Quezon City in session assembled: SECTION 1. CREATION - A Technical Committee is hereby created to conduct studies on the establishment of a polytechnic university of the Quezon City Government. SECTION 2. COMPOSITION OF THE TECHNICAL COMMITTEE -The Technical Committee shall be composed of the following: The Quezon City Mayor - Chairman a. The Quezon City Vice Mayor - Co-Chairman b. The Chairman of the Committee on Education - Vice-Chairman, and as Members: d. The Quezon City Treasurer e. The Director of the Bureau of Higher Education (DECS) Former President of the University of the Philippines who is a resident of Quezon City g. Representative of the Pamantasan ng Lungsod ng Maynila h. Representative of the Technological University of the Philippines i. Representative of the Polytechnic University of the Philippines j. Four (4) members of the Quezon City Council (one each from the four (4) Districts) to be designated by the Presiding Officer

SECTION 3. COMMITTEE FUNCTIONS - Based on its findings, the Technical Committee shall undertake the following:

- 1. To define the general framework of the proposed polytechnic university of Quezon City;
- 2. To specify the objectives and purposes of the proposed polytechnic university;
- 3. To define the academic programs and services;
- 4. To determine the academic structure for the operation of the polytechnic university;
- 5. To formulate policies pertaining to admission of students, hiring of faculty and staff employees, and other university personnel;
- 6. To design physical and technical plans for the polytechnic university campus;
- 7. To draft the proposed polytechnic university charter for congressional action;
- 8. To identify sources of funds and other financial means for the operational viability of the university;

9. To engage the services of technical expert groups that will assist the Technical Committee in pursuit of its tasks:

10. To submit a comprehensive report of the study within six (6) months from the date of effectivity of this Ordinance.

SECTION 4. APPROPRIATION - The sum of TWO HUNDRED FIFTY THOUSAND (\$250,000.00) PESOS, or so much thereof as may be necessary, is hereby appropriated to be used by the Technical Committee in its work, subject to availability of funds.

SECTION 5. EFFECTIVITY - This Ordinance shall take effect upon its approval.
