APPROVING THE THIRTY TWO (32) NEW POSITIONS AND ONE (1) RECLASSIFIED POSITION IN THE STAFFING PATTERN OF THE CITY CIVIL REGISTRY OFFICE; AND APPROPRIATING OUT OF THE GENERAL FUND THE SUM OF \$314,971.00 FOR SALARIES AND/OR SALARY DIFFERENTIALS ACCRUING TO SUCH POSITIONS COVERING THE PERIOD FROM NOVEMBER 19, 1987 TO JUNE 30, 1988.

WHEREAS, on October 26, 1987, thirty two (32) new positions and one (1) reclassified position were incorporated in the staffing pattern of the City Civil Registry Office to fully implement Section 169 (2) and 189 of the Local Government Code;

WHEREAS, on November 19, 1987, these positions were accordingly filled up and the corresponding salaries and/or salary differentials accruing thereto have not as yet been paid up to the present time;

WHEREAS, in view of the necessity of these new positions in the functional efficiency of the City Civil Registry Office and inasmuch as there is now available the necessary amount to cover payment of salaries and/or salary differentials for such positions:

NOW, THEREFORE

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. The thirty two (32) new positions and one (1) reclassified position in the staffing pattern of the City Civil Registry Office is hereby approved.

SECTION 2. There is hereby appropriated out of the General Fund the sum of Three Hundred Fourteen Thousand Nine Hundred Seventy One Pesos (#314,971.00) for salaries and/or salary differentials due and payable to such positions covering the period from November 19, 1987 to June 30, 1988.

SECTION 3. This Ordinance shall take effect upon its approval. ENACTED May 26, 1988.
