ORDINANCE NO. NC - 50, S-88

ORDINANCE

CREATING THE POSITION OF CITY FINANCE COORDINATOR, FRO-VIDING FOR HIS COMMENSATION, POWERS AND DUTIES AND APPRO-PRIATING THE NECESSARY FUNDS FOR THE FURIOSE.

Introduced by Councilor Guillerno C. Altuna

Be it ordained by the City Council of Quezon City in session assembled:

- SECTION 1. Creation of City Finance Coordinator. There is hereby created one (1) position of CITY FINANCE COCRDINATOR which shall be under the supervision and control of the City Mayor.
- SECTION 2. Appointment and Compensation. Subject to Civil Service Laws, the City Finance Coordinator shall be appointed by the City Mayor and confirmed by the Council. He shall received a salary, allowance and other emoluments equivalent to those being received by other Department Heads of the City Government.
- SECTION 3. Powers and Duties. The City Finance Coordinator shall perform the following functions:
 - (a) Advise the City Mayor, the City Council and other city officials the management of city financial resources and obligations;
 - (b) Coordinate the formulation of fiscal plans in support to the city development plans and see to it that funds are made available for current and mandatory appropriations;
 - (c) Coordinate with fiscal and collecting agencies to ensure that all taxes and other revenues are collected;
 - (d) Study revenue administration of the city and recommend measures to improve its revenue sources, tax effort, and collection efficiency;
 - (e) Advise the City Mayor and the other city officials on the effect of proposed appropriation ordinances, resolutions and other financial commitments;
 - (f) Monitor the financial and physical accomplishments of funded programs in relation to their work and financial plans and approved appropriations;
 - (g) Submit reports as may be required by the City Mayor or authorized agency; and

(h) Perform such other duties as may be prescribed by law or the City Mayor.

SECTION 4. The appropriation for salary, allowances and other mandatory personal expenses for the position of ity Budget Officer in the amount of \$83,604.00 are hereby reverted to the General Fund.

SECTION 5. There is hereby appropriated the sum of EIGHTY THREE THOUSAND SIX HUNDRED FOUR PESOS (#83,604.00) to cover the payment of the salary, allowances and other mandatory personal expenses of the City Finance Coordinator created under Section 1 hereof computed as follows:
