Be it ordained by the City Council of Quezon City in session assembled:

Government is hereby designated to conduct studies on the revision of the quezon City Charter, as amended, and to submit to the City Council a proposed Revised Charter of quezon City which shall be forwarded to Congress for the enactment of the necessary legislation thereon.

SECTION 2. The Committee may engage the services of legal,, technical and/or support staff to assist it in the performance of its tasks.

SECTION 3. The Committee shall submit its report and the proposed Revised Charter of Quezon City within a period of three (3) months from the approval of this Ordinance.

STOTION 4. The amount of One Hundred Fifty Thousand Pesos (7150,000.00), or so much thereof as may be necessary, is hereby alloted from the Special Activities Fund of the Office of the City Mayor to cover the expenses for consultancy, research and other necessary expenses of the aforesaid purpose.
