ORDINANCE

APPROPRIATING THE AMOUNT OF FOUR HUNDRED EIGHTY TWO THOUSAND NINE HUNDRED FIFTY FOUR PESOS AND FORTY CENTAVOS (P482,954.40) FOR THE SALARIES AND WAGES OF 32 REGULAR POSITIONS AND 25 CASUAL POSITIONS IN THE CITY CIVIL REGISTRY OFFICE.

WHEREAS, the City Civil Registry Office fulfills a vital role in serving the city residents in particular and the public in general, even while it is one of the major arms of the local government in generating much needed revenues;

WHEREAS, on October 26, 1987, thirty-two (32) new positions were incorporated in the staffing pattern of the City Civil Registry Office to fully implement Sections 169 (2) and 198 of the Local Government Code, and filled up on November 19, 1987;

WHEREAS, funding for the aforesaid positions covering the period from November 19, 1987 to June 30, 1988 was provided for under Ordinance No. 35, S-88 enacted on May 26, 1988;

WHEREAS, there has been no fund appropriated yet for the positions cited to cover the period from July 1, 1988 to December 30, 1988;

WHEREAS, in addition to the present personnel complement of the City Civil Registry Office an additional 25 casual positions are needed to fully attend to burgeoning responsibilities of the office brought about by the increasing city population and business activities;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. There is hereby appropriated from any available fund of the City Treasury the amount of FOUR HUNDRED EIGHTY TWO THOUSAND NINE HUNDRED FIFTY FOUR PESOS AND 40/100 (P482,954.40) for the salaries and wages of 32 regular positions and 25 casual positions in the City Civil Registry Office, specifically broken down as follows:

- a. 32 Regular Positions - P382,170.00 (For the period July 1 to December 30, 1988)
- b. 25 Casual Positions - P100,784.40 (For the period October 1 to December 30, 1988).

SECTION 2. This Ordinance shall take effect upon its approval.
