ORDINANCE NO. NC- 58, S - 88

ORDINANCE

CREATING CERTAIN POSITIONS TO SERVE AS THE STAFF OF THE COMMITTEE ON LAWS, RULES AND INTERNAL GOVERNMENT OF THE CITY COUNCIL; AND PROVIDING THE SUM OF SEVENTY SIX THOUSAND FIVE HUNDRED (P76,500.00) PESOS FOR THE PURPOSE.

Introduced by Councilors Jorge L. Banal, Guillermo C. Altuna, Alberto M. Galarpe and Ricardo R. Del Rosario;

Sponsored by Councilors George M. Canseco, Jose J. Faculdo, Dante V. Liban, Emilio G. Tamayo, Teodoro N. Ramos, Melencio M. Castelo and Isidro R. Saludes.

WHEREAS, the Committee on Laws, Rules and Internal Government of the City Council is the clearing house of all the other committees on question of laws, parliamentary issues and other highly technical questions concerning existing and proposed ordinances and resolutions;

WHEREAS, there is a strong need for an office in the city government that could fully accomodate the volume of legal, parliamentary and technical questions that need to be exhaustively studied and resolved with dispatch for the smooth and efficient operation of the City Council;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

Section 1. There is hereby created the following positions which shall serves as the staff of the Committee on Laws, Rules and Internal Government of the City Council;

One (1)	Legislative Assitant at	P8,000 each/month
Two (2)	Technical Assistant at	6,000 each/month
one (1)	Technical Researcher at	3,000 each/month
One (1)	Legislative Coordinator/ Stenographer at	2,500 each/month

PROVIDED, that appointments to be issued in pursuance of the above-mentioned positions shall be on a contractual basis; Provided, further, that appointments to said positions shall be with the concurrence of the majority members of the Committee on Laws, Rules and Internal Government and Provided, Furthermore, that preference shall be given to Quezon City residents.

Section 2. There is hereby appropriated from any available funds in the City Treasury the sum of Seventy Six Thousand

Five Hundred Pesos (P76,500.00), or so much thereof as may be necessary, to be made available for the payment of the compensation of the position created in Section One hereof covering the period from October 1 to December 31, 1988.

Section 3. This ordinance shall take effect upon its approval.
