Ordinance No. NC - 59, S - 88

ORDINANCE

APPROPRIATING THE AMOUNT OF TWO HUNDRED SEVEN THOUSAND THREE HUNDRED EIGHTY FOUR PESOS (P207,384.00) TO COVER THE SALARY DIFFERENTIAL OF VARIOUS MEDICAL GROUPS IN THE CITY HEALTH DEPARTMENT.

Introduced by Councilors Jorge L. Banal and Cielito "Mahal" E. Del Mundo.
Co-Sponsored by Councilors Eduardo F. David, George Canseco, Jose J. Paculdo, Isidro R. Saludes, Reynaldo A. Calalay, and Dante V. Liban.

WHEREAS, the salaries of various medical groups in the City Health Department was modified by the Metro Manila Commission in a letter dated November 5, 1987 to correct discrepancies/disparities in pay with the para-medical positions;

WHEREAS, the salary adjustment appropriately commenced on July 1, 1986, the date of effectivity of salary adjustments for the para-medical group;

WHEREAS, in view of the financial capability of the city government, only the salary differential covering the period October 1, 1987 to December 31, 1987 was provided under Supplemental Budget No. 2, NC -46, S -1988;

WHEREAS, as certified by the City Treasurer funds are now available to cover the salary differential covering the past period of July 1, 1986 to December 31, 1986;

WHEREAS, the remaining balance in the amount of TWO HUNDRED EIGHT THOUSAND FOUR HUNDRED SEVENTY PESOS (P208,470.00) will be included in the regular budget for CY 1989;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. There is hereby appropriated the amount of TWO HUNDRED SEVEN THOUSAND THREE HUNDRED EIGHTY FOUR PESOS (P207,384.00) to cover the salary differentials of various medical groups in the City Health Department this City, covering the period July 1, 1986 to December 31, 1986, the amount to be taken from salary savings of the same department (City Health) for CY 1988.
