ORDINANCE

APPROVING SUPPLEMENTAL BUDGET NO. 4 UNDER THE GENERAL FUND INVOLVING TWENTY-SIX MILLION SEVEN HUNDRED FORTY FOUR THOUSAND FIVE HUNDRED THIRTY-THREE PESOS (\$26,744,533.00) AND SUPPLEMENTAL BUDGET NO. 3 UNDER THE INFRASTRUCTURE FUND INVOLVING FOUR-TEEN MILLION FOUR HUNDRED SEVENTY-ONE THOUSAND FOUR HUNDRED NINETY-SIX FESCS (P14,471,496.00) TO COVER THE PAYMENT OF THE PRIOR YEARS OBLIGATIONS AND CURRENT YEAR EXPENSES OF THE VARIOUS OFFICES AND ACTIVITIES OF THE CITY GOVERNMENT; AND PROVIDING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Quezon City in session assembled:

Section 1. Supplemental Budget No. 4 under the General Fund for the Calendar Year 1988 involving TWENTY-SIX MILLION SEVEN HUNDRED FORTY-FOUR THOUSAND FIVE HUNDRED THIRTY-THREE PESOS (\$26,744,533.00) for the payment of prior years obligations and current year expenses of the various offices and activities of the City Government is hereby approved. The document containing the purposes and the detail of the expenditures is attached herewith and is hereby made an integral part of this ordinance,

Section 2. Supplemental Budget No. 3 under the Infrastructure Fund for the Calendar Year 1988 involving FOURTLEN MILLION FOUR HUNDRED SEVENTY-ONE THOUSAND FOUR HUNDRED NINETY-SIX PESCS (\$14,471,496.00) for the payment of prior years obligations and current year expenses of the various offices and activities of the City Government is hereby approved. The document containing the purposes and the detail of the expenditures is attached herewith and is hereby made an integral part of this ordinance.

Section 3. There is hereby appropriated from the General Funds the sum of TVENTY-NINE MILLION SIX HUNDRED NINETY-SIX THOUSAND TVENTY-NINE PESOS (P29,696,029.00), cut of this sum TVENTY-SIX MILLION SEVEN HUNDRED FORTY-FOUR THOUSAND FIVE HUNDRED THIRTY-THREE PESOS (P26,744,533.00) shall be made available to cover the expenses provided for in Section Cne hereof, while the remaining TWO MILLION NINE HUNDRED FIFTY-ONE THOUSAND FOUR HUNDRED NINETY-SIX PESOS (P2,951,496.00) shall be transferred to the Infrastructure Fund, the total sum to be taken from the funds certified as available for appropriation by the City Treasurer.

Section 4. There is hereby appropriated the sum of FOURTEEN MILLION FOUR HUNDRED SEVENTY-ONE THOUSAND FOUR HUNDRED NINETY-SIX PESOS (P44,471,496.00) to be made available to cover the expenses provided for in Section 2 hereof, the amount of ELEVEN MILLION FIVE HUNDRED TWENTY THOUSAND PESOS (P11,520,000.00) to be taken from the Infrastructure Funds certified as available for appropriation by the City Treasurer and the amount of TWO MILLION NINE HUNDRED FIFTY-ONE THOUSAND FOUR HUNDRED NINETY-SIX PESOS (P2,951,496.00) to be taken from the sum transferred under Section 3 of this Ordinance.

Section 5. This Ordinance shall take effect upon its approval.
