ORDINANCE

ESTABLISHING A POLICE SUB-STATION AT PROJECT 4, QUEZON CITY AND APPROPRIATING THE AMOUNT OF ONE MILLION FIVE HUNDRED FORTY SIX THOUSAND AND FOUR HUNDRED PESOS (P1,546,400.00) AS FINANCIAL ASSISTANCE FOR THE PURPOSE.

WHEREAS, Project 4, Quezon City has a population of over 45,000 as compared to the combined population of Project 2 and 3 which is only 30,000;

WHEREAS, the Cubao Sub-Station and Quirino-Substation, presently having jurisdiction on Project 4, cover so vast an area as to adequately and effectively answer the demands of peace and order in Project 4;

NOW, THEREFORE,

Be it ordained by the City Council of Quezon City, in session assembled:

SECTION 1. There is hereby established the Project 4 Sub-Station No. 9 to cover the area bounded by: on the West-20th Ave., Bonnie Serrano, E. De Los Santos Avenue (EDSA) up to Mandaluyong-Pasig Boundary; on the East-Marikina-Quezon City Boundary; and on the South-Pasig-Quezon City Boundary.

SECTION 2. The Project 4 Sub-Station will be set up at the front of Project 4 Market.

SECTION 3. There is hereby appropriated from any available fund of the City Treasury the sum of ONE MILLION FIVE HUNDRED FORTY-SIX THOUSAND AND FOUR HUNDRED PESOS (P1,546,400.00) as financial assistance specifically for the following purposes:

a. Office Equipment	P127,400.00
b. Communication Equipment	27,000.00
c. Vehicular Support	192,000.00
d. Construction of a 120 sq. meter 2 storey Sub-station	1,200,000.00
