ORDINANCE NO. 9388, S-72

ORDINANCE

PREScribing THE RATES OF FEES TO BE COLLECTED FOR CERTAIN SERVICES RENDERED BY THE LOCAL CIVIL REGISTRY OF QUEZON CITY, AND FOR OTHER PURPOSES.

Introduced by Councilors Paredes, David,
Genito Jr. and P. Perlas.

Be it ordained by the Council of Quezon City in session assembled:

SECTION 1. The collection of the following fees for certain services rendered by the Local Civil Registry of Quezon City is hereby authorized:

1. Registration of Documents

a. Annulment of marriage	P50.00
b. Legal separation	50.00
c. Repatriation, or voluntary renunciation of citizenship	50.00
d. Decree of Naturalization	50.00
e. Foreign decree of adoption	50.00
f. Affidavit and/or Oath of allegiance of the wife and children of Filipino Citizens	20.00
g. Court decisions or orders to correct or change the entries in any certificate of birth, marriage or death	20.00
h. Voluntary emancipation of minors	20.00
i. Change of name	20.00
j. Aliases	20.00
k. Recognition or acknowledgment of natural children, or court decisions or orders empugning such recognition or acknowledgment	10.00
l. Judicial determination of paternity or filiation	10.00
m. Court decisions or orders on the custody of minors and/or guardianship	10.00
n. Other legal documents for record purposes	10.00

II. Additional Services

- a. For late registration of certificates of birth, marriage, delayed for a period of more than one (1) year P10.00
- b. For registration of supplementary report as additional data filed under Par. 21-a & b; Certificate of Live Birth (under Municipal Form No. 102, Revised December 1, 1953) 10.00
- c. For issuance of certificate; Filing of marriage application and other supporting papers 2.00
- d. For making photographic or xerox copies or by any similar process, of documents on file in the Local Civil Registry, per page for certification of its correctness 0.50
- e. For furnishing blank forms for application for marriage, per set of 4 sheets 1.00

III. Cadaver disposition, etc. Permit for:

- a. Entrance from another municipality P20.00
- b. Transfer to another municipality 10.00
- c. Cremation 5.00
- d. Exhumation 5.00
- e. Burial 5.00
- f. City cemetery 10.00

SEC. 2. All ordinances or parts thereof in conflict with this Ordinance, except that which grants free permit for pauper's burial, are hereby repealed and/or modified accordingly.

SEC. 3. This Ordinance shall take effect upon its approval.
