Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. Supplemental Budget No. 4, General Fund, in the amount of Eighty Million Seventy-Three Thousand Five Hundred Forty-Seven Pesos (P80,073,547.00) and Supplemental Budget No. 3, Infrastructure Fund, in the amount of Three Budget No. 3, Infrastructure Fund, in the amount of Three Million Sixty Thousand Pesos (P3,060,000.00), series of Million Sixty Thousand Pesos (P3,060,000.00), series of 1989, for a total of Eighty-Three Million One Hundred 1989, for a total of Eighty-Three Million One Hundred Thirty-Three Thousand Five Hundred Forty-Seven Pesos (P83, 133,547.00) covering various expenses of the Quezon City 133,547.00) covering various expenses of the Quezon City 133,547.00) are hereby approved.

SECTION 2. SECTION 5. In the implementation of this Ordinance priority shall be given to the rank and file employees of the Quezon City Government.
