ORDINANCE NO. SP- 2476 , S-2016

AN ORDINANCE RENAMING ANTIPOLO STREET OF BARANGAY KRUS NA LIGAS, QUEZON CITY TO TEODORO FULGENCIO STREET.

Introduced by Councilors JESUS MANUEL C. SUNTAY and MARVIN C. RILLO.

Co-Introduced by Councilors Vincent DG. Belmonte, Raquel S. Malañgen, Jessica Castelo Daza and Bayani V. Hipol.

WHEREAS, streets, avenues, boulevards, parks, playgrounds, historical spots and other public places are so named to give significance to the accomplishments and virtues of certain persons or to the historic importance of certain events;

WHEREAS, Section 13, paragraph b(2) of the Local Government Code of 1991 authorizes the Sanggunian of highly urbanized cities, in consultation with the National Historical Commission of the Philippines, to change the name of city roads, avenues, boulevards, thoroughfares, and bridges;

WHEREAS, Mr. Teodoro D. Fulgencio was the Teniente Del Barrio from 1954 to 1969 of Barrio Krus Na Ligas and headed several organizations from 1974 to 2000;

WHEREAS, he was a prominent leader and a legitimate resident of Barangay Krus Na Ligas, Quezon City;

WHEREAS, the Barangay Council of Barangay Krus Na Ligas adopted Barangay Resolution No. 52, series of 2013 entitled: "Barangay Resolution earnestly changing/replacing the street name of Antipolo Street located at Sitio Lambak to Teodoro Fulgencio in honor of the late Teodoro Fulgencio, a bonafide, legitimate prominent resident of Sitio Lambak, Krus Na Ligas, this city";

WHEREAS, the life of Mr. Teodoro D. Fulgencio should be the object of inspiration and emulation by the public, especially public servants;

WHEREAS, in order to immortalize his name, virtue, and accomplishments to our society, it is most befitting to use his name on a street in Quezon City so that motorists and pedestrians from all over the Metro Manila and from different parts of the country may remember him, and his contributions to the people of Barangay Krus Na Ligas.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGUAR SESSION ASSEMBLED:

SECTION 1. Antipolo Street in Barangay Krus na Ligas, District IV, this City, is hereby renamed as "Teodoro Fulgencio Street".

SECTION 2. To avoid the inconvenience that may arise in the delivery of postal matters and in guiding people accustomed to the old name, "Antipolo Street" shall be printed at the bottom of the signage "T. Fulgencio Street" for at least two (2) years.

SECTION 3. The Office of the President, the Congressman of the 4th District of Quezon City and the Director of the Postal Services Office, as well as all agencies concerned, shall be notified of this Ordinance pursuant to Section 13, paragraph (h) of the Local Government Code of 1991.
