AN ORDINANCE AMENDING SECTION 2 (C) OF ORDINANCE NO. SP-1986, S-2009, INCREASING THE CASH INCENTIVE GRANT FROM TEN THOUSAND PESOS (PHP10,000.00) TO ONE HUNDRED THOUSAND PESOS (PHP100,000.00) TO ALL QUEZON CITY REGISTERED RESIDENT SENIOR CITIZENS UPON REACHING THE AGE OF ONE HUNDRED (100).

WHEREAS, on December 14, 2009, the Quezon City Council approved Ordinance No. SP-1986, S-2009 entitled, "An Ordinance Giving Due Recognition and Reward to City Residents Aged 100 Years or More as part of the City's effort to Support Senior Citizens";

WHEREAS, Section 2 (C) of the said Ordinance provides for the grant of Ten Thousand Pesos (Php10,000.00) as cash incentive to each centenarian citizens of our City, to wit:

"SECTION 2 (C) – Upon presentment of proper and authentic documents, the city government will grant each of the centenarian an amount of Ten Thousand Pesos (P10,000.00) cash incentive."

WHEREAS, Republic Act No. 10868 was signed into law last 23 June 2016, granting a cash gift in the amount of P100,000 and a letter of felicitation from the President to all Filipinos who shall reach the age of 100;

WHEREAS, to provide recognition and full support to our resident senior citizens who have attained the age of 100 or three (3) decades beyond the life expectancy of 70 years, there is a need to increase the cash incentive being given to them from Ten Thousand Pesos (Php10,000.00) to One Hundred Thousand Pesos (Php100,000.00).

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Section 2 (C) of Ordinance No. SP-1986, S-2009, increasing the cash incentive grant from Ten Thousand Pesos (Php10,000.00) to One Hundred Thousand Pesos (Php100,000.00) to all Quezon City registered, resident Senior Citizens upon reaching the age of One Hundred (100).
