

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF BISTEKVILLE – 4 (SOCIALIZED HOUSING PROJECT) WITH TWELVE (12) WALK-UP BUILDINGS, LOCATED AT LOT 644-A-7-D, (LRC) PSD-32238, VARGAS LANE, METRO HEIGHTS COMPOUND, BARANGAY CULIAT, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF QUEZON CITY GOVERNMENT COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2015014687 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF NINE THOUSAND TWO HUNDRED (9,200) SQUARE METERS, AS APPLIED FOR AND REPRESENTED BY MR. 
