

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF SIPAG VILLE PHASE I HOMEOWNERS ASSOCIATION, INC., WITH ONE HUNDRED THIRTY NINE (139) LOTS COMMUNITY MORTGAGE PROGRAM (CMP) REGISTERED IN THE NAME OF FELICITAS S. SILAYAN MARRIED TO FLORENTINO SILAYAN COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-194164 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING A PROJECT GROSS AREA OF FOUR THOUSAND SEVEN HUNDRED TWENTY TWO (4,722) SQUARE METERS AND LOCATED AT LOT 797-B-1-D, PSD-20434, PUROK 3, LUZON AVENUE, BARANGAY CULIAT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ITS PRESIDENT, MS. 




