ORDINANCE NO. SP. 2570 , S-2017

AN ORDINANCE NAMING THE EXISTING UNNAMED ROAD LOCATED IN BARANGAY SAN JOSE, DISTRICT 1 QUEZON CITY, PERPENDICULAR TO TENDIDO AND TINAGAN STREETS TO BRIGIDO VELASCO STREET IN RECOGNITION OF THE SERVICES RENDERED BY THE LATE PUNONG BARANGAY BRIGIDO VELASCO TO THE COMMUNITY AND CONSTITUENCY OF BARANGAY SAN JOSE.

WHEREAS, the Sangguniang Barangay of Barangay San Jose, District 1 of this City, has passed Resolution No. 84, S-2016 expressing the desire to name the existing unnamed barangay road thereat to Brigido Velasco Street;

WHEREAS, a copy of Barangay San Jose Resolution No. 84, S-2016 is hereto attached as annex "A":

WHEREAS, according to the said Resolution, the late Brigido Velasco, aside from once serving as Tinyente del Barrio in the said area in the 1970's and the very first appointed Barangay Captain during Marcos Regime, has established the very first school of Barangay San Jose, the San Jose Elementary School, including the creation of San Jose High School and Health Center;

WHEREAS, Honorable Brigido Velasco regained office after winning the Barangay Elections of 1989 and held the position until his death in 1998, highlighting almost ten (10) years of his unblemished record of public service and selfless contribution to the community;

WHEREAS, consultation with the National Historical Institute was already made regarding the desire to name the existing unnamed barangay road;

WHEREAS, the desire to name the existing unnamed barangay road is, in part, prompted by nationalistic sentiments on the part of the Sangguniang Barangay;

WHEREAS, naming the existing unnamed barangay road to Brigido Velasco will serve to commemorate and honor a man who, by the account of his own community, has served as a good example to the citizenry.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The existing unnamed barangay road in Barangay San Jose, perpendicular to Tendido and Tinagan Streets is hereby named as "Brigido Velasco Street."

SECTION 2. PUBLIC NOTIFICATION – The Office of the President, the Representative of the Legislative District concerned, the Director of the Postal Services Office, and the Metropolitan Manila Development Authority (MMDA), as well as all other agencies concerned, shall be notified of the change in name of city roads as per Section 13, paragraph (h) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

SECTION 3. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval.
