AN ORDINANCE AMENDING ORDINANCE NO. SP-1551, S- 2005, APPROVING THE SECOND ( $2^{ND}$ ) ALTERATION PLAN OF SITIO STO. NIÑO CHESTNUT WEST FAIRVIEW QUEZON CITY, INC., TO BE ALTERED INTO THE PROPOSED SUBDIVISION PLAN OF BISTEKVILLE - 6 (SOCIALIZED HOUSING PROJECT) WITH 116 LOTS AND 3 CLUSTER WITH 108-UNIT (WALK-UP, 2-STOREY RESIDENTIAL BLDG.) LOCATED AT LOT 8, BLOCK 16; LOT 16, BLOCK 12; AND PORTION OF ROAD LOT 11, SITIO STO. NIÑO, CHESTNUT STREET, WEST FAIRVIEW, BARANGAY FAIRVIEW PARK, QUEZON CITY, REGISTERED IN THE NAME OF THE CITY GOVERNMENT OF QUEZON CITY, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-295825, N-295826 AND RT-128203 (172926) PR-46414 OF THE REGISTRY OF DEEDS OF OUEZON CITY, CONTAINING AN AREA OF SIXTEEN THOUSAND EIGHT HUNDRED NINETY (16,890) SQUARE METERS, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BILANG 220.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED.

SECTION 1. The second (2nd) Alteration Plan of Sitio Sto. Niño Chestnut West Fairview Quezon City, Inc., to be altered into the Proposed Subdivision Plan of Bistekville - 6 (Socialized Housing Project) with 116 Lots and 3 Clusters with 108-Units (Walk-up, 2-Storey Residential Bldg.) located at Lot 8, Block 16; Lot 16, Block 12; and portion of Road Lot 11, Sitio Sto. Niño, Chestnut Street, West Fairview, Barangay Fairview Park, Quezon City, registered in the name of the City Government of Quezon City, covered by Transfer Certificates of Title Numbered N-295825, N-295826 and RT-128203 (172926) PR-46414 of the Registry of Deeds of Quezon City, containing an area of Sixteen Thousand Eight Hundred Ninety (16,890) square meters, as applied for and represented by Mr. Tadeo M. Palma, Secretary to the Mayor/Chairman, LGU-QC Task Force Housing, in compliance with the minimum requirements of the Implementing Standards, Rules and Regulations of Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Bilang 220, is hereby approved, details of which are as follows:
