WHEREAS, Ordinance No. SP-2273, S-2014, otherwise known as "An Ordinance Adopting the Seal of Good Housekeeping in all Barangays of Quezon City" was approved by the 19<sup>th</sup> Quezon City Council on February 10, 2014;

WHEREAS, Ordinance No. SP-2273, S-2014 was amended by Ordinance No. SP-2523, S-2016, so as to include the other awards and citations, publication of the Quezon City Barangay Seal of Good Housekeeping (QCBSGH) book and other incentives:

WHEREAS, on its second year of implementation, the QCBSGH Assessment Team commenced its task to assess the 142 barangays in the City from October 25 to December 8, 2016. The team was composed of the representatives from the following:

1. Office of the Vice Mayor
2. Office of the Secretary to Sangguniang Panlungsod (OSSP)
3. Barangay Operations Center
4. Environmental Protection and Waste Management Department (EPWMD)
5. DILG-Quezon City Field Office
6. City Accounting Department
7. City Budget Department
8. City Public Affairs and Information Services Office (PAISO)

WHEREAS, the conferment of the award was held on December 16, 2016 at the UP Bahay ng Alumni. The Dangal ng Lungsod awards were conferred to two (2) barangays and the Huwarang Pamamahala were awarded to four (4) barangays;

WHEREAS, special citations were conferred to nine (9) barangays with noteworthy performance of Barangay-Based Institutions, seven (7) Barangays with Best Practices, eleven (11) Barangays with Good Financial Housekeeping, and eleven (11) Barangays with Legislative Services Citation; ✓

WHEREAS, the post evaluation by the Technical Working Group yielded some issues and concerns and recommendations for the implementation of the ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 2 (A) Gawad sa Huwarang Pamamahala Award (c) (1) of Ordinance No. SP-2273, S-2014, as amended by Ordinance No. SP-2523, S-2016, is hereby amended to read as follows:

" c). Accountable Governance

1. Passed the financial management assessment of the City Accounting Department (at least 80%) and the assessment conducted by the City Budget Department.

SECTION 2. (B) Dangal ng Lungsod Award (c) (1) of Ordinance No. SP-2273, S-2014, as amended by Ordinance No. SP-2523, S-2016, is hereby amended to read as follows:

c). Accountable Governance

1. Passed the financial management assessment of the City Accounting Department (at least 80%) and the assessment conducted by the City Budget Department.

SECTION 2 (B) Dangal ng Lungsod Award (d) (1) of Ordinance No. SP-2273, S-2014 is hereby amended to read as follows:

d). Participatory Governance

1. Functionality of the mandatory Barangay Based Institutions: Barangay Peace and Order Committee (BPOC), Barangay Development Council (BDC), Barangay Anti-Drug Abuse Council (BADAC), Barangay Ecological Solid Waste Management Committee (BSWMC), Barangay Council for the Protection of Children (BCPC), Gender and Development (GAD), Barangay Disaster Risk Reduction and Management Council (BDRRMC), and the Barangay Nutrition Council.”

SECTION 2. Section 4 of Ordinance No. SP-2273, S-2014 is hereby amended to read as follows:

“SECTION 4. CREATION OF A TECHNICAL WORKING GROUP – There shall be created a technical working group to be composed of the following:

- a). City Mayor or his/her duly authorized representative;
- b). City Vice Mayor or his/her duly authorized representative;
- c). City Council Secretary;
- d). Barangay Operations Center;
- e). City Budget Officer;
- f). City Accountant;
- g). DILG Quezon City Field Office Director;
- h). Head, Environmental Protection and Waste Management Department (EPWMD) or his/her duly authorized representative;
- i). Head, Quezon City Health Department or his/her duly authorized representative;
- j). Quezon City Disaster Risk Reduction Management Officer or his/her duly authorized representative; and

k). Chairperson of the Quezon City Anti-Drug Abuse Advisory Council or his/her duly authorize representatives;"

SECTION 3. Section 5 of Ordinance No. SP-2273, S-2014, as amended by Section 2 of Ordinance No. SP-2523, S-2016, is hereby amended to read as follows:

"SECTION 5. ANNUAL APPROPRIATION – The amount of Twenty Million Pesos (Php20,000,000.00) is hereby appropriated to be taken from any available funds of the City Mayor subject to existing accounting and auditing rules and regulations, and for the following purposes, to wit:

- a. Cash award;
- b. Operational cost of the Technical Working Group;
- c. Event and awarding ceremony;
- d. Book publication;
- e. Special citations; and
- f. Plaque."


SECTION 4. HALL OF FAME AWARD – Barangays who are conferred with the Dangal ng Lungsod Award for three (3) consecutive assessment years only shall be entitled to the Hall of Fame Award and a cash incentive in the amount of Five Million Pesos (Php5,000,000.00) in lieu of the usual cash incentive award of Five Hundred Thousand Pesos (Php500,000.00). If the barangay has qualified for the Dangal ng Lungsod Award on the next assessment year after receiving the Hall of Fame Award, the barangay is still entitled to be conferred with usual incentive intended for the level of the Seal.

The incentive provided herein shall be used to fund the priority programs and projects of both national and local government thrust and priorities subject to the guidelines prescribed in the Implementing Rules and Regulations of this Ordinance. y


SECTION 5. Within thirty (30) days from the approval of this ordinance, the Technical Working Group shall formulate and issue the supplemental rules and regulations necessary for the effective and efficient implementation of this Ordinance.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect immediately upon its approval.




