AN ORDINANCE DECLARING CRESTA VERDE EXECUTIVE SUBDIVISION, LOCATED AT BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, AS AN OPEN COMMUNITY.

WHEREAS, Cresta Verde Executive Subdivision, located at Barangay Sta. Monica, Novaliches, Quezon City, is a private residential subdivision managed by a Homeowners' Association and was duly constituted and registered with the Housing and Land Use Regulatory Board (HLURB);

WHEREAS, the Board of Directors and Officers of Cresta Verde Executive Homeowners' Association, Inc. (CVESHAI), through its Board Resolution No. 1, Series of 2015, conveyed their request to the Quezon City Government that their subdivision be classified or declared as an open community, as it would not cause prejudice to the homeowners and would be more beneficial to their cause as it is expected to pave the way for an individual water connection with the Maynilad, among others;

WHEREAS, the Barangay Council of Barangay Sta. Monica, through its approved Resolution No. 471, Series of 2015, endorses to the Quezon City Council the aforementioned Board Resolution of Cresta Verde Executive Homeowners' Association, Inc., and this is a manifestation that they interpose no objection to the request of the said association;

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:

SECTION 1. Declaration - The Cresta Verde Executive Subdivision located at Barangay Sta. Monica, Novaliches, Quezon City is hereby declared an open community.

SECTION 2. Separability Clause - If any provision or part hereof is held invalid or unconstitutional, the remainder of this Ordinance or the provisions not otherwise affected shall remain valid and subsisting.




SECTION 4. *Effectivity Clause* - This Ordinance shall take effect immediately upon its approval.




