ORDINANCE

APPROPRIATING SEVENTY-FIVE THOUSAND PESOS FOR THE  
INSTALLATION OF THIRTY-NINE FIRE HYDRANTS WITHIN  
QUEZON CITY, THE AMOUNT TO BE TAKEN FROM THE GENERAL  
FUND.

Introduced by the Chairman, Committee on  
Public Safety

Be it ordained by the Council of Quezon City  
in session assembled:

Section 1. There is hereby appropriated from  
the general fund, the sum of Seventy-Five Thousand

Pesos (P75,000.00), or so much thereof as may be  
necessary for the installation of thirty-nine (39)
