ORDINANCE NO. SP- 2647, S-2017

AN ORDINANCE PROHIBITING PUBLIC UTILITY VEHICLES (PUVs), UV EXPRESS VEHICLES, TRUCKS, TAXI CABS AND ALL TRANSPORT VEHICLES FROM PARKING ALONG THE STREETS OF BARANGAY KAUNLARAN AND DECLARING ONE-SIDE PARKING, NO PARKING, ONE-WAY TRAFFIC DIRECTION AND REGULATED PARKING ON CERTAIN STREETS OF THE BARANGAY.

Introduced by Councilor RAQUEL S. MALAÑGEN.

Co-Introduced by Councilors Marvin C. Rillo, Irene R. Belmonte, Marra C. Suntay, and Hero Clarence M. Bautista.

WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides for the Powers, Duties, Functions of the Sangguniang Panlungsod;

"(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx."

"(vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles, thereon and, when necessary in the interest of public welfare, xxx."

WHEREAS, the Sangguniang Barangay of Barangay Kaunlaran Passed Ordinance No. 008, S-2017, entitled:

"BARANGAY ORDINANCE PROHIBITING PUBLIC UTILITY VEHICLES (PUVs), UV EXPRESS VEHICLES, TRUCK TAXI CABS AND ALL TRANSPORT VEHICLES FROM PARKING ALONG THE STREETS OF BARANGAY KAUNLARAN AND DECLARING ONE-SIDE PARKING, NO PARKING, ONE-WAY TRAFFIC DIRECTION AND REGULATED PARKING ON CERTAIN STREETS OF THE BARANGAY";

WHEREAS, the barangay experiences massive complaints due to the continuous problem of vehicular traffic on a daily basis;

WHEREAS, aside from illegal parking and obstruction, there has been a growing complaint from the residents of this Barangay regarding illegally parked vehicles such as trucks, taxi cabs, UV Express vehicles and PUV's, which pose not only danger to passers-by but most of the time causes unsanitary and unpleasant situation such as, drivers peeing thereat, sleeping inside the vehicles while feet are stretched out and others;

WHEREAS, an orderly flow of traffic and organized parking of vehicles, per street is also necessary to give way quickly to emergency response vehicles to arrive on time especially during fire and evacuation, as well as during emergency situations like sending a resident to the hospital;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. SCOPE/COVERAGE

A) One-side parking shall be observed on the following streets of Barangay Kaunlaran:


- a. Batay - left side coming from Arayat/PA Bernado Street;
- b. Cristobal - right side coming from Arayat/PA Bernardo Street;
- c. Driod - right side coming from Arayat/PA Bernardo Street;
- d. Natib - left side coming from Arayat/PA Bernardo Street;
- e. Monte de Piedad - right side coming from Aurora Boulevard; ✓

- f. Boston - left side coming from Aurora Boulevard;
 - g. Manga Road - left side coming Aurora Boulevard;
 - h. Driod Extension - right side coming from Arayat/PA Bernardo Street
 - i. Mataba - right side from Arayat/PA Bernardo Street
 - j. St. John - left side coming from N. Domingo Street
 - k. St. Peter - right side coming from P. Tuazon Boulevard
 - l. Planas Site 1 - left side coming from P. Tuazon Boulevard
 - m. Planas Site 1 - right side coming from P. Tuazon Boulevard
 - n. Planas Site 3 - right side coming from P. Tuazon Boulevard
- B) No Parking Zone shall be observed on the following streets:
- a. Mayor IS Diaz Street, formerly Banahaw Street, from C. Benitez to N. Domingo
 - b. P. Tuazon Boulevard from N. Domingo To EDSA
 - c. Balete Drive
 - d. Rosario Drive/Betty Go Belmonte
 - e. Seattle
 - f. N. Domingo
 - g. Hemady
- C) One-Way Traffic Direction shall be observed on the following streets:
- a. Monte de Piedad- with the traffic direction coming from Seattle going to Aurora Boulevard; 

- b. Boston- with the traffic direction coming from Aurora Boulevard;
 - c. Rosario Drive/Betty Go- with the traffic direction coming from N. Domingo
 - d. Manga Road- with the traffic direction coming from Rosario Drive/Betty Go
 - e. Planas Site 2- with the traffic direction coming from P. Tuazon Boulevard
- D) Double Parking of vehicles is allowed for bonafide residents only on the following streets if and only if the One-side Parking has been fully completed:
- a) St. John Street
 - b) Cristobal Street
- E) Regulated Parking shall be allowable only from 10:00 PM to 6:00 AM on the following Streets:
- a) Domingo - right side coming from P. Tuazon Boulevard
 - b) Hemady – right side coming from N. Domingo

SECTION 2. PENALTY/VIOLATION - Violators of this Ordinance shall be metted with the following:

- First Offense: Violation ticket plus clamping
- Second Offense: Fine of 800 Pesos plus clamping
- Third Offense: Fine of 1500 Pesos plus towing





SECTION 4. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval.


