AN ORDINANCE ESTABLISHING THE VITO L. BELARMINO SENIOR HIGH SCHOOL LOCATED AT SALALILLA STREET, BARANGAY MILAGROSA, PROJECT 4, QUEZON CITY.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that "the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, under the revised guidelines of the National Historical Commission of the Philippines, proposed names of public schools, among others, "must have historical and cultural significance and must contribute to the positive development of national pride through the good example exhibited by the name being used";

WHEREAS, Republic Act No. 10533 or the Enhanced Basic Education Act of 2013 broadened the goals of basic education to include college preparation, vocational and technical career opportunities as well as creative arts, sports and entrepreneurial employment. This will be through the Senior High School Program where students will choose one among these Tracks: Academic, Arts and Design, Technical-Vocational and Sports;

WHEREAS, in view thereof, there is a need to establish senior high schools to accommodate students and to effectively implement the Senior High School Program;

WHEREAS, the Local School Board (LSB), through Resolution No. 3, Series of 2017 recommended to name the Senior High School located at Barangay Milagrosa, as the Vito L. Belarmino Senior High School;

WHEREAS, Vito L. Belarmino Senior High School aims to initially offer the Sports Track;

WHEREAS, Vito L. Belarmino born in Silang, Cavite was one of the most brilliant Major-General of the revolutionary, involved in a number of attacks againts the Spaniards. At age 19, he entered government service and held various positions such as Teniente Mayor, Cabeza de Barangay, Secretary of the local tribunal and Gobernadorcillo. He was later appointed as the Justice of Peace;


WHEREAS, Belarmino was struck blind in 1928 and grew a reputation for being able to help sick people by means of taking their pulse. He was, at the time, called "The Blind Veteran";

WHEREAS, in honor of his legacy, the senior high school to be established at Barangay Milagrosa, shall be named as the Vito L. Belarmino Senior High School.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There is hereby established under the Quezon City Schools Division Office a Public Senior High School located at Barangay Milagrosa, Project 4, to be known as the Vito L. Belarmino Senior High School

SECTION 2. The supplemental budget necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 3. In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
