AN ORDINANCE CREATING THE POSITIONS OF TWO DETECTIVES, ONE MASTER PLUMBER, AND ONE ELECTRICAL INSPECTOR, AND APPROPRIATING THE SUM OF TWO THOUSAND SEVEN HUNDRED TEN PESOS (P2,710.00) FOR THEIR SALARIES AND BONUSES FROM THE PERIOD FEBRUARY 8, 1947 TO JUNE 30, 1947.

Be it ordained by the City Council of Quezon City, that:


SECTION 1. The following positions are hereby created and the salaries of each are herein fixed as follows:

Two (2) Detectives at P960 per annum	- P 800.00
One (1) Master Plumber at P1440 per annum	- 600.00
One (1) Electrical Inspector at P1440 per annum	- 600.00
Contribution to Government Service Insurance System	60.00
For Bonus	650.00
Total	P 2,710.00


SEC. 2. The sum of TWO THOUSAND SEVEN HUNDRED TEN PESOS (P2,710.00) or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the salaries, bonuses and government contribution to the Government Service Insurance System, of the positions created in Section 1 hereof, for the period commencing February 8, 1947 to June 30, 1947.

SEC. 3. This Ordinance shall take effect upon its approval.

The sum of TWO THOUSAND SEVEN HUNDRED TEN PESOS (P2,710.00) or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the salaries, bonuses and government contribution to the Government Service Insurance System, of the positions created in Section 1 hereof, for the period commencing February 8, 1947 to June 30, 1947.
