ORDINANCE NUMBER 6 AS AMENDED BY ORDINANCE NO. 136,
139 and 1307.

SECTION 1. The fees for building permit is hereby fixed as follows:

(a) Repealed by Ordinance No. 139.

SEC. 2. The fees for plumbing permit is hereby fixed as follows:

(a) Ordinance No. 136 Sec.1 Letter (a) of Section 2, Ordinance No. 6, current series, is hereby amended to read as follows:

"For a unit composed one (1) water closet, one (1) lavatory, one (1) sink, two (2) floor drains, two (2) faucets, one (1) shower head, one (1) water meter, and one (1) septic vault, a fee of ₱10.00 shall be collected.

SEC. 2-A Ordinance No. 1307. Nothing in this Ordinance shall be construed prohibiting the issuance of a permit after the plumbing work or house drainage, including removal or transfer of any existing fixture as well as addition of the plumbing system, for which said permit is needed has already been commenced, provided said plumbing work or house drainage is not in violation of any plumbing ordinance, but in such cases a surcharge of twenty per centum (20%) over the ordinary fees shall be collected from the applicant".

SEC. 3. Any person, firm or corporation who commences or proceeds with the erection, construction, building, reconstruction, enlarging, alteration, changing, adding to, repairing, building upon, moving, removal or demolition of any buildings or structure or install any plumbing fixtures to such buildings or prescribed in this Ordinance, shall be punished by a fine of not more than two hundred pesos (₱200.00) or by imprisonment of not more than six (6) months, or by both, at the discretion of the Court.

SEC. 4. All Ordinances or parts of Ordinances which are in conflict with the provisions of this Ordinance are hereby repealed.

SEC. 5. This Ordinance shall take effect upon its approval.

SEC. 3. Any person, firm or corporation who commences or proceeds with the erection, construction, building, reconstruction, enlarging, alteration, changing, adding to, repairing, building upon, moving, removal or demolition of any building or structure or install any plumbing fixtures to such buildings or structures without paying the necessary permit fixed and prescribed in this Ordinance, shall be punished by a fine of not more than two hundred pesos (₱200.00) or by imprisonment of not more than six (6) months, or by both, at the discretion of the Court.

SEC. 4. All Ordinances or parts of Ordinances which are in conflict with the provisions of this Ordinance are hereby repealed.

SEC. 5. This Ordinance shall take effect upon its approval.

SEC. 2. The fees for plumbing permit is hereby fixed as follows:

(a) Ordinance No. 136 Sec.1 Letter (a) of Section 2, Ordinance No. 6, current series, is hereby amended to read as follows:

"For a unit composed one (1) water closet, one (1) lavatory, one (1) sink, two (2) floor drains, two (2) faucets, one (1) shower head, one (1) water meter, and one (1) septic vault, a fee of P10.00 shall be collected.

SEC. 2-A Ordinance No. 1307. Nothing in this Ordinance shall be construed prohibiting the issuance of a permit after the plumbing work or house drainage, including removal or transfer of an existing fixture as well as addition of the plumbing system, for which said permit is needed has already been commenced, provided said plumbing work or house drainage is not in violation of any plumbing ordinance, but in such cases a surcharge of twenty per centum (20%) over the ordinary fees shall be collected from the applicant".

SEC. 3. Any person, firm or corporation who commences or proceeds with the erection, construction, building, reconstruction, enlarging, alteration, changing, adding to, repairing, building upon, moving, removal or demolition of any buildings or structure or install any plumbing fixtures to such buildings or prescribed in this Ordinance, shall be punished by a fine of not more than two hundred pesos (P200.00) or by imprisonment of not more than six (6) months, or by both, at the discretion of the Court.

SEC. 4. All Ordinances or parts of Ordinances which are in conflict with the provisions of this Ordinance are hereby repealed.

SEC. 5. This Ordinance shall take effect upon its approval.

ORDINANCE Numbered 6

AN ORDINANCE FIXING THE FEES FOR BUILDING AND PLUMBING PERMITS IN QUEZON CITY, AND PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF.

Be it ordained by the City Council of Quezon City that:

SECTION 1. The fees for building permit is hereby fixed as follows:

a. For the first thirty (30) square meters of floor area there shall be charged ₱6.50 and for every square meter in excess of the original thirty (30) square meters, ₱0.26.

SEC. 2. The fees for plumbing permit is hereby fixed as follows:

a. For a unit composed of one (1) water closet, two (2) faucets and one (1) showerhead, a fee of ₱10.00 shall be collected.

b. For every fixture in excess of the above unit, the following fees shall be collected:

5.	"	" (1) faucet	-----	0.50

9.	"	" (1) bath tub	-----	2.00
10.	"	" (1) grease trap	-----	2.00

c. The following fees shall be collected for plumbing inspections:

1. For every inspection of water test - ₱5.00
2. For every inspection of connection to new sewer - - - - - 2.00
3. For every inspection of connection of a single fixture to the existing installation - - - - - 1.00
