ORDINANCE NO. SP- 2738, S-2018

*AN ORDINANCE IMPOSING A ONE PESO (P1.00) INCREASE ON THE ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY COVERING THE MONTH OF SEPTEMBER 2018, THE PROCEEDS THEREOF TO BE DONATED TO THE GIRL SCOUTS OF THE PHILIPPINES, QUEZON CITY COUNCIL, TO SUPPORT ITS NUMEROUS PROGRAMS AND ACTIVITIES.*

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission Fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (P1.00) covering the month of September 2018.


SECTION 2. All concerned movie/cinema owners and operators are hereby authorized to transmit and turn-over to the GSP-Quezon City all sum of money collected and the GSP-Council will account for all such money received and submit to the City Treasurer of Quezon City official receipts and such other pertinent records as maybe required in the acknowledgment thereof, subject to the usual accounting regulations. The City Treasurer is directed to submit the corresponding report to the City Council in connection therewith.

SECTION 3. Upon its approval, copy of this Ordinance will be furnished to the Quezon City Treasurer, the GSP-Quezon City Council and all cinema owners and operators doing business in Quezon City, for their information and proper guidance.




