
AN ORDINANCE ALLOWING ONE-SIDE STREET PARKING AND ONE-WAY TRAFFIC SCHEME IN P. BURGOS STREET OF BARANGAY ESCOPA I AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 16 of the Local Government Code of 1991 provides that:

"Every local government unit shall exercise the powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient governance, and those which are essential to the promotion of the general welfare. Within their respective jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among residents, maintain peace and order and preserve the comfort and convenience of their inhabitants";

WHEREAS, the Sangguniang Barangay of Barangay Escopa I passed a Barangay Resolution entitled "A Resolution strongly urging the City Council to pass an Ordinance allowing only one-side parking and One-way in P. Burgos Street of Barangay Escopa I, with penalties in violation thereof;"

WHEREAS, the use of both sides of the streets for parking creates traffic bottlenecks unnecessary delays and loss of precious man-hours considering the width of the road and the volume of the vehicles passing through Barangay Escopa I;

WHEREAS, the residents of the area are affected by the irresponsible parking of vehicles on both sides of the streets even on driveways especially by non-residents of Escopa I;

WHEREAS, the Sangguniang Barangay enacted a resolution regulating the parking of vehicles in P. Burgos St., and allowing one-side parking in answer to various complaints of residents who are affected by the irresponsibly parked vehicles on both sides of the streets even on driveways;

WHEREAS, the Sangguniang Barangay requested the Department of Public Order and Safety (DPOS), Quezon City for comments and suggestions, getting response in return with the suggestions that one-side parking be imposed on the left side of the road going to Aurora Boulevard and one-way also going to Aurora Boulevard.


## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known as the "One Side Street Parking and One-Way Traffic Scheme in P. Burgos Street of Barangay Escopa I."

SECTION 2. It is hereby prohibited to park on both sides in Barangay Escopa I and declaring a One-Way Traffic Scheme in P. Burgos Street going to Aurora Boulevard.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS – The Department of Public Order and Safety (DPOS) of Quezon City shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 4. Violation of Section 2 of this Ordinance shall be penalized by the following:

1<sup>ST</sup> Offense

Five Hundred Pesos (PHP500.00)

2<sup>nd</sup> Offense

One Thousand Pesos (PHP1,000.00)

3rd Offense

Impounding of Vehicle

SECTION 5. REPEALING CLAUSE – All Ordinances, Resolutions, Rules and Regulations inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon its approval.
