ORDINANCE NO. SP- **2795**, S-2018

AN ORDINANCE IMPOSING ONE PESO (P1.00) INCREASE TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY COVERING THE PERIOD FROM MARCH 1 TO 31, 2019, THE PROCEEDS THEREOF ARE TO BE DONATED TO THE ROTARY FOUNDATION OF ROTARY INTERNATIONAL DISTRICT 3780 TO SUPPORT ITS CAUSE ORIENTED PROGRAMS AND ACTIVITIES IN CELEBRATION OF THE 100th YEAR OF THE ROTARY INTERNATIONAL IN THE PHILIPPINES.

WHEREAS, the Rotary International District 3780 has numerous cost oriented programs and activities in Quezon City involving blood donations, provision for clean drinking water for various schools in Quezon City, Botika sa Barangay, disaster preparedness and assistance, programs on health, hunger and poverty alleviation, literacy and education, environmental protection, search for outstanding policemen, nutrition and many other laudable activities beneficial to the residents of Quezon City;

WHEREAS, in 2016, in recognition of its valuable programs and activities that have benefited numerous residents and communities in Quezon City, the 20th Quezon City Council enacted City Ordinance No. SP-2534, S-2016, imposing One Peso (P1.00) increase to admission fees in all cinemas in Quezon City covering the period from November 1 to 30, 2016, the proceed thereof to be donated to the Rotary Foundation of Rotary International District 3780 to support its civic programs and activities in recognition of the 100th Year of the Rotary Foundation;

WHEREAS, to show the unwavering support of the Quezon City Government to the Rotary International District 3780 as they celebrate the 100th Year of the Rotary International in the Philippines, the City again intends to increase the admission fees in all cinemas in Quezon City by One Peso (P1.00), the proceeds of which shall be donated to the Rotary Foundation to support various civic organizations and to help finance its programs and activities that will ultimately benefit the needy residents and communities of Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas/ movie houses in Quezon City are hereby increased by One Peso (P1.00) from March 1 to 31, 2019.

SECTION 2. The proceeds of the admission fee increase as prescribed in Section 1 hereof shall be donated to the Rotary Foundation of Rotary International District 3780 to support its civic programs and activities.

SECTION 3. All Cinemas shall remit directly within 30 days, after March 31, 2019, to the City Treasurer the amount collected under this Ordinance.

SECTION 4. The City Treasurer's Office shall take appropriate action for the proper implementation of this Ordinance. ✓





SECTION 5. This Ordinance shall take effect upon its approval.




