ORDINANCE NO. SP- 2759, S-2018

AN ORDINANCE ALLOWING THE NEW TRAFFIC SCHEME OF BARANGAY QUIRINO 2-B TO MAKE ONE-WAY STREET TRAFFIC ROUTING AND ONE SIDED STREET PARKING, PRESCRIBING PENALTIES AND SANCTION THEREOF.

WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides for the Powers, Duties, Functions of the Sangguniang Panlungsod:

- (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx.
- (vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, xxx;

WHEREAS, the Sangguniang Barangay of Barangay Quirino 2-B passed Resolution No. 119, S-2017 entitled, "A RESOLUTION REQUESTING THE CITY COUNCIL TO ENACT AN ORDINANCE FOR BARANGAY QUIRINO 2-B TO MAKE ONE-WAY STREET TRAFFIC ROUTING AND ONE SIDE-STREET PARKING AND PRESCRIBING PENALTIES AND SANCTION THEREOF, FOR SAFETY ORDER AND FOR OTHER PURPOSES";

WHEREAS, in accordance with the General Welfare Clause of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the safety and well-being of the Barangay shall be the first in Barangay Governance;

WHEREAS, there was an increase in the number of vehicles that passes through Barangay Quirino 2-B which causes continuous traffic problems within its streets, taking also in consideration the numerous schools situated in the said barangay;

WHEREAS, there is a necessity to implement a new traffic scheme to prevent chaos and to maintain peace and order in the community and streets within Barangay Quirino 2-B.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE - This Ordinance shall be known and referred to as "NEW TRAFFIC SCHEME OF BARANGAY QUIRINO 2-B."

SECTION 2. COVERAGE - All motorist, residents and non-residents, passing through the streets of Barangay Quirino 2-B are required to obey this new Barangay Traffic Scheme. x

SECTION 3. The New Traffic Scheme:

A) Streets with one-way traffic flow:

1. Bignay St. is one way from Langka St. to Anonas St.
2. Durian St. is one way from Anonas to Langka St.
3. Lanzones St. is one way from Durian St. to Anonas St.
4. Marang St. is one way from Anonas St. to Guyabano St.
5. Naranghita St. is one way from Guyabano to Anonas St.
6. Tampoy St. is one way from Pajo St. to Anonas St.
7. Tampoy St. is one way from corner of Langka St. to Barangay Hall.

B) Streets with one sided alternative parking:

1. Bignay St.
2. Durian St. from Lanzones St. to Langka St.
3. Marang St.
4. Guyabano St.

C) Streets with one sided parking only:

1. Durian St. from Anonas St. to Lanzones St.
2. Lanzones St. from Durian St. to Anonas St.
3. Tampoy St. from Pajo St. to Anonas St. ✓

D) No Parking tow away zone:

1. All Alleys

E) Streets with both side Parking:

1. Pajo St.
2. Chico St.

SECTION 4. PENALTIES – All penalties, fines or surcharges shall be the same as those prescribed under Ordinance No. SP-1444, Series of 2007 for motor vehicle violations.

SECTION 5. DEPUTATION – authorized personnel to implement this Ordinance are:

- a. Punong Barangay
- b. Barangay Kagawad Chairperson on Peace and Order
- c. Barangay Public Safety Officer (BPSO)

- Implementation shall be on a 24/7 basis unless there is a need to suspend in particular areas only for reasons of emergencies like fire, calamities, disasters and fiesta or special occasions.

SECTION 6. REPEALING CLAUSE – All ordinances, resolutions, executive orders, memorandum circulars and all other issuances or parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE – If for any reason, any provision of this Ordinance is declared invalid or unconstitutional, other parts or provisions hereof shall continue to be in full force and effect. X





SECTION 8. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval.




