AN ORDINANCE RECLASSIFYING A PARCEL OF LAND IDENTIFIED AS LOT 257-C; PSD-20281, LOCATED AT HOWMART ROAD, BARANGAY BAESA, QUEZON CITY FROM IT'S CURRENT CLASSIFICATION TO RESIDENTIAL CLASSIFICATION.

WHEREAS, the aforesaid property was already declared as Socialized Housing Site under SP-2526, Series of 2016;

WHEREAS, the present occupants of the abovementioned property is requesting the Quezon City Government to sell the Five Thousand (5,000) Square Meters in their favour and develop the same into a Socialized Housing Project;

WHEREAS, the said property is classified by the City Planning and Development Office as Medium Density Industrial (I-2) Zone;

WHEREAS, there is a need to reclassify the zoning of said property from its current zoning to residential zoning before the Quezon City Government can develop and use the said parcel of land into a socialized housing project to solve the present urban poor dwelling problem of the City in accordance with the provisions of the Local Government Code of 1991 and Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN


SECTION 2. The City Planning and Development Office is hereby directed to make the necessary specifications in accordance herewith,

SECTION 3. This Ordinance shall take effect upon its approval.




