ORDINANCE NO. SP- 2655 , S-2018

AN ORDINANCE ESTABLISHING THE EMILIO D. JACINTO SENIOR HIGH SCHOOL TO BE LOCATED AT BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that "the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, under the revised guidelines of the National Historical Commission of the Philippines, proposed names of public schools, among others, "must have historical and cultural significance and must contribute to the positive development of national pride through the good example exhibited by the name being used";

WHEREAS, Republic Act No. 10533 or the Enhanced Basic Education Act of 2013 broadened the goals of basic education to include college preparation, vocational and technical career opportunities as well as creative arts, sports and entrepreneurial employment. This will be through the Senior High School Program where students will choose one among these Tracks: Academic, Arts and Design, Technical-Vocational and Sports;

WHEREAS, in view thereof, there is a need to establish senior high schools to accommodate students and to effectively implement the Senior High School Program;

WHEREAS, the City Planning and Development Office has identified four thousand two hundred seven square meters and sixty square decimeters (4,207.60 sq.m.) land with Lot No. 715-A-5 (LRC) Psd-11798 located at Barangay Pasong Tamo as a site for the construction of a Senior High School in Barangay Pasong Tamo;

WHEREAS, the Local School Board (LSB), through Resolution No. 3, Series of 2017 recommended to name the abovementioned school as the Emilio D. Jacinto Senior High School;

WHEREAS, the Emilio D. Jacinto Senior High School aims to initially offer the following: Academic Track: General Academic Strand, Technical-Vocational Livelihood Track: Beauty/Nail Care, Wellness & Massage, and Hairdressing;


WHEREAS, Emilio D. Jacinto, known as the "Utak ng Katipunan" served as a fiscal adviser and secretary to the Katipunan or the Kataas-taasang, Kagalang-galang na Katipunan ng mga Anak ng Bayan, a revolutionary group during the Spanish colonization of the country which fought for the Philippines to gain independence;

WHEREAS, he authored the Kartilya ng Katipunan, a guidebook for members of the Katipunan which stipulates its rules and principles;

WHEREAS, in honor of his legacy, the senior high school to be constructed in Barangay Pasong Tamo will be named as the Emilio D. Jacinto Senior High School.

NOW, THEREFORE,

SECTION 1. There is hereby established under the Quezon City Schools Division Office a Public Senior High School located at Philand Subdivision, Barangay Pasong Tamo, to be known as the Emilio D. Jacinto Senior High School.

SECTION 2. The supplemental budget necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 3. In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
