ORDINANCE NO. SP- 2813 , S-2019

AN ORDINANCE DECLARING THE ABANDONED ROAD LOTS, ALLEYS, EASEMENT AND OPEN SPACES OF CARMEL III SUBDIVISION, BARANGAY TANDANG SORA, QUEZON CITY, AS PUBLIC USE PROPERTIES OF THE QUEZON CITY GOVERNMENT PURSUANT TO THE PROVISIONS OF CITY ORDINANCE NO. SP-2298, S-2014, AS CERTIFIED BY THE CITY PLANNING AND DEVELOPMENT OFFICE.

WHEREAS, the subdivision developer, Carmel Corporation, failed to turn-over the road lots and open spaces of the said Subdivision to the Quezon City Government;

WHEREAS, the Securities and Exchange Commission (SEC) issued a certification that the registration of Carmel Corporation expired on January 5, 2006;

WHEREAS, the road lots, drainage system and open spaces of Carmel III Subdivision are in bad condition and needs major repair;

WHEREAS, City Ordinance No. SP-2298, S-2014 declared abandoned roads, alleys, open spaces and excess lots in all subdivisions in Quezon City as properties for public use by the City Government, thereby setting the guidelines for the use thereof and for other purposes;

WHEREAS, on August 13, 2018, the City Planning and Development Office certified that Carmel III Subdivision is an abandoned subdivision pursuant to the provisions of City Ordinance No. SP-2298, S-2014.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Pursuant to the provisions of City Ordinance No. SP-2298, S-2014, it is hereby declared that the abandoned road lots, alleys, easements and open spaces of Carmel III Subdivision located at Barangay Tandang Sora, Quezon City, as public use properties of the Quezon City Government.

SECTION 2. Carmel III Subdivision herein declared as abandoned subdivision shall be subject to the conditions prescribed under City Ordinance No. SP-2298, S-2014.

SECTION 3. The City Mayor is hereby authorized to cause the repair and maintenance of road lots, alleys, easements and open spaces of Carmel III Subdivision, Barangay Tandang Sora, Quezon City, which were abandoned by the subdivision developer.

SECTION 4. This Ordinance shall take effect upon its approval.
