AN ORDINANCE GRANTING ADDITIONAL INCENTIVE TO ALL PLANTILLA POSITION EMPLOYEES OF THE QUEZON CITY GOVERNMENT EQUIVALENT TO ONE (1) MONTH SALARY TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, with the sound financial management of the City, it is high time that the salaries of employees must be taken into consideration;

WHEREAS, due to the increase in the prices of basic commodities, the grant of additional incentive to all plantilla position employees of the Quezon City Government is imperative.
