ORDINANCE NO. SP- 2881 , S-2019

AN ORDINANCE ALLOWING THE NEW TRAFFIC SCHEME OF BARANGAY STO. CRISTO, DISTRICT I, QUEZON CITY TO MAKE ONE-WAY TRAFFIC SCHEME ALONG THE PORTION OF PANGASINAN STREET BETWEEN THE CORNERS OF MINDORO STREET AND ILOILO STREET AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the Powers, Duties, Functions of the Sangguniang Panlungsod:

- (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx.
- (vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, xxx;

WHEREAS, the Sangguniang Barangay of Barangay Sto. Cristo, District I, Quezon City, passed a Resolution No. 017, Series of 2019, entitled "A Barangay Resolution Urging the City Council to Enact A "One-Way Traffic Scheme" Ordinance Along the Portion of Pangasinan Street Between the corners of Mindoro Street and Iloilo Street";

WHEREAS, Barangay Sto. Cristo is experiencing heavy traffic during the school hours and rush hours, in arteries going to SM City North EDSA and Sto. Cristo Elementary School, particularly along Ilocos Sur Street;

WHEREAS, there is as need to prescribe a systematic, organized and fully implementable mechanism of maximizing the limited road space available to ensure the smooth and unhampered flow of traffic;

WHEREAS, there is a necessity to implement a new traffic scheme to prevent chaos and to maintain peace and order in the community and streets within Barangay Sto. Cristo.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known as the "One-Way Traffic Scheme" Along the Portion of Pangasinan Street Between the Corners of Mindoro Street and Iloilo Street."

SECTION 2. COVERAGE. - All motorists, residents and non-residents passing through the streets of Barangay Sto. Cristo are required to obey this new Barangay Traffic Scheme.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. - The Department of Public Order and Safety (DPOS) of Quezon City, Barangay Traffic Enforcer and Barangay Public Safety Officers of Barangay Sto. Cristo shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 4. PENALTIES. - All penalties, fines or surcharges shall be the same as those prescribed under Ordinance No. SP-2785, Series of 2018 for motor vehicle violations.

SECTION 5. DEPUTIZATION. - Authorized personnel to implement this Ordinance are:

a. Punong Barangay

b. Barangay Kagawad who is the Chairperson of the Committee on Peace and Order

c. Barangay Public Safety Officer (BPSO)

Implementation shall be on a 24/7 basis unless there is a need to suspend in particular areas only for reasons of emergencies such as, but not limited to fire, calamities, disasters and fiesta or special occasions.

SECTION 6. REPEALING CLAUSE. – All ordinances, resolutions, executive orders, memorandum circulars and all other issuances or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.
