ORDINANCE NO. SP- 2878 , S-2019

AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 2020 IN THE AMOUNT OF TWENTY-SEVEN BILLION EIGHT HUNDRED THIRTY-SIX MILLION PESOS (PHP27,836,000,000.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. APPROVAL. - The Annual Budget of the Quezon City Government for Calendar Year 2020 is hereby Approved in the amount of Twenty-Seven Billion Eight Hundred Thirty-Six Million Pesos (Php27,836,000,000.00) covering the various expenditures for the operation of the City Government.

 - 7. Personnel Schedule.

SECTION 2. APPROPRIATION. - The amount of Twenty-Seven Billion Eight Hundred Thirty-Six Million Pesos (Php27,836,000,000.00), or so much thereof, is hereby appropriated from the General Fund as may be necessary to be taken from the Estimate of Revenue certified as available by the City Treasurer as contained in the budget documents.

SECTION 3. SEPARABILITY CLAUSE. - If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, all other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.
